



SPECIFIC RULES TO COMBAT THE SPREAD OF COVID-19

(Valid from November 26th, 2021)

1. The Ticket Holder and/or user undertakes to adopt and respect the prevention and protection measures in place, established due to the need to restrict the spread of COVID-19 - including undergoing a body temperature measurement at the Stadium entrance - along with targeted measures to prevent common respiratory tract infections, following the precautions identified by the WHO and by the National Health Authority and, in any case, respecting the instructions received from the Club as stated below:

- Without prejudice to the cases of exclusion provided for by the legislation (art. 9-bis paragraph 3 of D.L. 52/2021 as amended by D.L. 172/2021), access to the Stadium is only allowed to persons with one of the green certifications COVID-19 referred to in art. 9-bis paragraph 1 of D.L. 52/2021.

In addition, without prejudice to any amendments to the legislation, from 29 November 2021 in the yellow and orange zones, and from 6 December 2021 to 15 January 2022 also in the white zone, Access to the Stadium is only allowed to the subjects referred to in articles 5 and 6 of D.L. 172 of 26/11/2021 or to the subjects with one of the green certifications COVID-19 referred to in art. 9, paragraph 2 letters a, b, c-bis of D.L. 52/2021 (so-called "Super Green Pass"), to subjects under the age of 12 and subjects exempt from the vaccination campaign.

- You may not enter the Stadium if you have tested positive for COVID-19, are subject to any measure of mandatory or self-imposed quarantine, have any symptoms of COVID-19 (including, but not limited to, body temperature > 37.5°C, cough, weakness, breathing difficulty, muscle pain, diarrhoea, change of taste or smell) or have been in close contact with anyone who has shown symptoms or has tested positive for COVID-19 in the 14 days prior to the event;
- in order to avoid crowd gatherings at the Stadium entrance, the Ticket Holder and/or user must enter through the access gates following the entry methods and timescales indicated on the ticket itself;
- the body temperature will be taken at the Stadium entrance; if the temperature is > 37.5°C, the Ticket Holder/user will not be permitted to enter the event and must immediately return home, contact the GP and comply with all instructions provided;
- inside the Stadium you must always respect the spatial distance of 1 metre, even when entering and exiting;
- during the event, you must remain seated in your assigned numbered seat;
- you must always wear a face mask, even when entering and exiting. The general rules apply to children;
- Spectators must adopt hygienic behaviour and must clean and sanitise their hands and personal belongings with the utmost care. They must also ensure respiratory hygiene, for example covering their faces when sneezing;

- alcohol-based hand gel solutions are available inside the stadium for hand cleanliness. We recommend that you wash your hands frequently;
- if a catering and/or bar service is provided, you can consume food and drinks under the terms and in the manner established by the legislation and/or guidelines and/or regulations and/or protocols issued by the relevant authorities for the prevention and containment of Covid -19;
- the Ticket Holder and/or user must promptly and responsibly inform the stewarding staff present in the Stadium of any onset of flu-like symptoms or COVID-19 symptoms arising whilst inside the Stadium, remaining an adequate distance away from other persons present, keep wearing the face mask, comply with any temporary isolation in a dedicated room and follow the instructions given until the competent medical staff can intervene.

2. The Ticket Holder and/or user is fully aware of all risks involved in attending the event and, by virtue thereof, assumes exclusive responsibility for all the aforementioned risks, expressly indemnifying and holding harmless the Club from any consequence that may result from attending the sports event and, in any case, any other related activity, even as a consequence of any personal behaviour.

3. Any violation of the prevention rules listed above and/or failure to respect the instructions of the stewards in charge of supervising respect of the same constitutes "Relevant Conduct" that may be sanctioned with the "institution of approval" in accordance with the Code of Conduct.
