



# Terms and Conditions of Use

By “Website” we refer to the [www.juventus.com](http://www.juventus.com) Internet site and all related sub-domains.

By “App” we refer to the application officially named “Juventus Official App” currently available to be downloaded from the various e-stores, as well as additional applications that may be released in the future by Juventus.

By “Services” we refer to the services provided by Juventus through the Website and/or the App, free of charge or against payment of the foreseen amount, in accordance with the relative General Conditions of Service, and which differ from the normal browsing of the public content to be found on the Website and App. For example, paid services include the pay-per-view content of the audio-visual media service of the Juventus TV section of the Website, Juventus Membership, Juventus Card, reservation of a parking space at the Allianz Stadium, services related to the purchase of admission tickets to the Allianz Stadium, etc.

“User” refers to any visitor or user of the Website.

By “Terms and Conditions of Use” we refer to the terms and conditions of use of the Website and App set out below.

The Website and App are offered by Juventus Football Club S.p.A. (henceforth known as “Juventus”) with legal offices in Via Druento 175, 10151 Turin, tax code, Vat No and Turin Company Registry no. 00470470014.

The sections of the Website (sub-domains) related to the “Academy” and the ticketing service (“Ticketing”) are offered and are under the control and management of Juventus’ partners and licensees as detailed in their respective sections.

The following Terms and Conditions of Use govern access to the Website and the App and their use, and access to all the materials and information of whatever kind published on the Website and the App (including, by way of example, informative articles, photographs, images, illustrations, audiovisual content, henceforth referred to as “Content”). Furthermore, special terms and conditions of use shall apply to access specific Services and/or Content, or specific content, data, materials or information that the user supplies by interacting with the Website and/or App (henceforth referred to as “User Content”) or to transactions completed via the Website. These Terms and Conditions of Use are therefore integrated by the dispositions, terms and conditions indicated in each case for access to specific sections of the Website or App, to take





advantage of specific Services such as for example Juventus TV [ <https://www.juventus.com/it/termini-e-condizioni/#juventus-tv> ] or to purchase specific services and products.

### **Acceptance of the Terms and Conditions of Use**

By accessing any part or section of the Website or App or by using the Website or App and its connected Services, the User accepts to be bound by these Terms and Conditions of Use, all terms and conditions contained or mentioned herein and any additional terms and conditions that may be indicated in each case for access to specific sections of the Website or App, to use specific Services or to purchase specific services and products.

### **Amendment of the Terms and Conditions of Use**

Juventus reserves the right to change these Terms and Conditions of Use at any time: the Terms and Conditions of Use as modified shall immediately apply at the time of publication. If the User continues to access or use the Website and/or App after their publication, it shall be understood that the User has accepted said changes. The user is advised to check the applicable terms and conditions on a regular basis. It is possible that other Juventus websites have their own specific terms and conditions of use, which apply to these same websites.

Juventus reserves the right to remove or amend or update the Website and/or App and the related Contents at any time and without any prior notice. Juventus reserves the right, at any time, with immediate effect, without any prior notice, at its own exclusive discretion and for whatever reason, to limit, refuse or interrupt, in full or in part, access to the Website and/or App, or part thereof, by any User.

The Laws having effect in the Republic of Italy shall apply to whatever not expressly provided herein.
